Dear Ms. Bull:

Kleinfelder, on behalf of Exxon Mobil Corporation (ExxonMobil), has prepared this Work Plan to conduct potable well sampling of select properties south of the above referenced location (Site). The potable wells proposed for sampling are listed in **Table 1** and depicted on **Figure 1**. As you are aware, municipal waterline connections are planned for 259 and 261 Old Bayview Road and sampling of these properties is proposed to verify previous sampling results and that no further action will be necessary.

Until the municipal waterline connections are completed, Arcadis, on behalf of ExxonMobil, will continue to sample the potable wells at 259 and 261 Old Bayview Road quarterly in accordance with Maryland Department of Environment (MDE) requirements for the Site. Details of the proposed sampling, reporting, and schedule are described below:

POTABLE WELL SAMPLING

Kleinfelder, on behalf of ExxonMobil, proposes to collect water samples from select nearby private potable wells as depicted on **Figure 1** for laboratory analysis. A written request for access to collect the water samples will be provided to each property owner listed in **Table 1**. The draft request for *Property Access for Potable Well Sampling* is attached and includes the proposed sampling procedure. Each well sample will be analyzed for full list volatile organic compounds (VOCs) including fuel oxygenates using Environmental Protection Agency (EPA) drinking water Method 524.2

REPORTING

A letter with the results of the potable well sampling will be submitted to the property owners, tenants (if present), MDE, and Cecil County Health Department following receipt of the analytical results.

SCHEDULE

Kleinfelder, on behalf of ExxonMobil, is prepared to initiate the proposed activities following written approval of this Work Plan from the MDE. Pending property owner approvals, it is anticipated that the results of the potable well sampling will be submitted to the MDE approximately 45 days from receipt of work plan approval. Kleinfelder will notify the MDE at least five days prior to the initiation of the field activities.

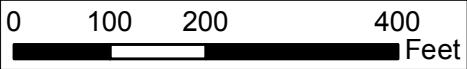
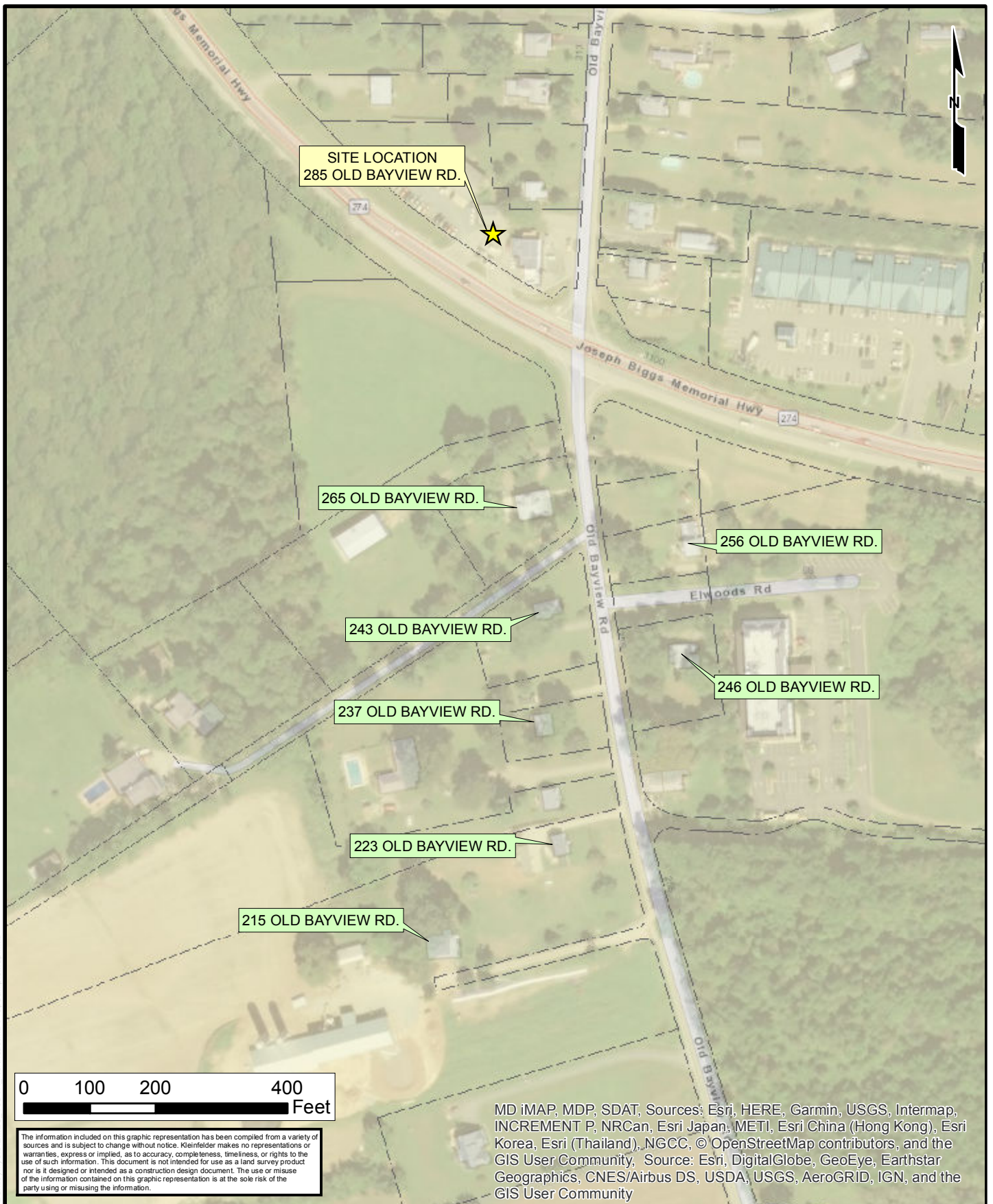

Dear (Property Owner):

Under the direction of the Maryland Department of the Environment (MDE), Exxon Mobil Corporation (ExxonMobil) is conducting an ongoing groundwater investigation associated with the former Mobil station on Old Bayview Road in North East, Maryland. As part of the investigation, Kleinfelder, on behalf of ExxonMobil, requests access to your property to collect a water sample from the drinking water well for analysis of gasoline constituents.

Following MDE guidelines, a representative of Kleinfelder will collect a water sample as close to the well as physically practical and, if possible, prior to the water going through any treatment or filtering devices. Usually, we are able to collect the water sample near the holding tank after allowing the water to flow long enough to flush the tank and lines. As described, this process typically takes approximately 20 minutes.

The sampling is planned for Tuesday, August 20, 2019 between the hours of 12 p.m. – 6 p.m. If you would like to schedule an appointment on this day for us to collect the sample, please contact me by email or at the toll-free number below.

ExxonMobil and Kleinfelder appreciate your cooperation and apologize for any inconvenience this may cause you. This work will be completed at no cost to you. You will receive a copy of the laboratory results of the tests run on the sample taken from your well. For reference, a water well sample access form is attached. Kleinfelder will request that the person granting access and property owner information be completed when we arrive for your sampling appointment to document your permission to the MDE.
