Groundwater & Environmental Services, Inc. (GES), on behalf of High's of Baltimore, LLC (High's), is pleased to submit the attached Sensitive Receptor Survey (SRS) Report for the High's Store No. 86, 3711 Federal Hill Road, Jarrettsville, Maryland (Site). The Maryland Department of the Environment (MDE) – Oil Control Program (OCP), sent High's a directive to complete a SRS in correspondence dated January 27, 2021.

The required elements of the SRS, as specified in the January 27, 2021 directive letter, are summarized below and will be addressed, individually, in subsequent sections of this correspondence:

- a) *Annotate the 660-ft (1/8-mile), 1,320-ft (1/4-mile) and 2,640-ft (1/2-mile) radii;*
- b) *Provide a summary table of well data including, at minimum: property addresses, owner name and address, well tag ID #, total depth of well, casing depth, screen depth, and current status of well usage;*
- c) *Review well completion reports and evaluate whether on-site conditions could potentially impact any off-site drinking water supply wells in the area;*
- d) *Submit documentation of which supply well are historic and have been abandoned;*
- e) *For properties served by public water, provide confirmation of this connection in the summary table (this can include confirmation from the Harford County Water and Sewer Authority of properties that receive a water bill);*
- f) *Submit copies of notes documenting field reconnaissance performed to verify presence/absence of wells; and*
- g) *Provide written documentation of your findings and the list of persons contacted.*



Annotated Maps

To assist with the references made within this SRS report, GES has included a Site Location Map as **Figure 1**, a Local Area Map as **Figure 2** and a Site Map as **Figure 3**.

In addition, to meet the MDE directive requirement for annotated maps, GES has prepared **1/8-mile, 1/4-mile and 1/2-mile Sensitive Receptor Survey Maps**, which are attached as **Figures 4, 5 and 6**, respectively. The SRS maps were drafted after review of well records obtained from both the Harford County Health Department (HCHD) and High's, from visual confirmations gathered during a GES field reconnaissance event on March 24, 2021, and from the desktop evaluation of online aerial imagery.

A total of 181 parcels were determined to exist within the 1/2-mile area surrounding the Site. Individual parcels within each of the three SRS maps (**Figures 4, 5 and 6**) are color-coded for the following criteria:

- Blue - Parcels with an existing drinking water (potable) supply well and with available well completion records (56 parcels).
- Green - Parcels verified with an existing potable supply well but with no available well completion records (66 parcels).
- Yellow - Parcels suspected to have a potable supply well, but with no visual verification of well, and no available well completion records (42 parcels).
- Gray - Parcels observed as unoccupied and/or undeveloped and no visual or recorded evidence of a potable supply well (17 parcels).

Each of the 181 parcels documented within the 1/2-mile radius of the Site are uniquely identified by a Tax ID number; therefore, each parcel presented within the SRS maps as **Figures 4, 5 and 6** have been labelled with a corresponding Tax ID number.

Sensitive Receptor Survey - Potable Well Summary Table

Based on review of the available potable supply well records, and supported by observations made from field reconnaissance and desktop evaluation, GES has prepared a comprehensive potable well summary table, attached as **Table 1**, that accounts for the 181 parcels found within a 1/2-mile radius of the Site. Tax ID numbers were used as the primary parcel identifier in **Table 1**. The supporting well records, as obtained from the HCHD and from High's, are organized by parcel address and included as **Appendix A**.



Discussion of On-site Conditions with Respect to Potential Impacts to Off-site Potable Supply Wells

The January 27, 2021 MDE directive was issued in response to exceedances of MDE groundwater cleanup criteria for dissolved benzene and methyl tert-butyl ether (MTBE) collected from onsite well MW-4, during a routine monitoring event conducted on October 9, 2020. (See Site Map – **Figure 3** for the location of the onsite monitoring wells.)

GES evaluated the October 9, 2020 analytical results in conjunction with the results of several confirmatory monitoring events held at the Site, from November through December 2020, and presented findings to the MDE in an *Interim Monitoring Report for Event Completed December 22, 2020*, dated February 19, 2021. A more recent GES monitoring report for the Site, the *First Quarter 2021 Monitoring Report*, was submitted to the MDE on April 1, 2021.

In summary, concentrations of benzene and MTBE, sampled over several successive events since the instance of elevated concentrations in October 2020, have significantly reduced at well MW-4. GES attributes these reductions to a revised sampling procedure (using a low-flow methodology) which will now be implemented for all three site monitoring wells, which includes well MW-4.

Based on a review of the data provided in the recent GES reports, review of historical monitoring reports, and from the MDE January 27, 2021 directive letter, GES has listed several considerations below regarding the potential for onsite conditions to impact off-site potable supply wells:

- The MDE's Oil Control Compliance Division found no evidence of an active or ongoing release at the Site based on compliance testing of the underground storage tank (UST) system on November 19, 2020.
- The direction of groundwater flow mapped among the three existing monitoring wells at the Site (MW-1, MW-3 and MW-4) has been reported to demonstrate both a north-to-south and a south-to-north flow direction, from one monitoring event to the next. This apparent reversal of groundwater direction may reflect a very localized flow condition at the Site. However, based on topography, groundwater leaving the Site would be expected to flow primarily north toward the East Branch Winters Run, which crosses Federal Hill Road approximately 650 ft north of the Site.
- Sampling of three adjacent, offsite potable supply wells on November 30, 2020, including 3707 (1700 Jarrettsville Road), 3713 and 3717 Federal Hill Road, did not demonstrate detections of petroleum constituents, with the exception of MTBE detected at the 3707/1700 address, at a concentration of 0.216 micrograms per liter ($\mu\text{g/L}$).
- Historical sampling of the potable supply well for the High's Store #86, positioned near the southern boundary of the Site, had not presented any past MTBE detections (beginning in 2013) until the most recent sampling event conducted by GES on February 15, 2021, at which time a concentration of 0.10 $\mu\text{g/L}$ MTBE was detected. This MTBE concentration, detected at the lower limit of the required EPA Method 524.2 analytical method for the constituent, was revealed due to a lower method detection limit (MDL) used by GES's selected laboratory for the Site (Eurofins Lancaster of Lancaster, PA).



- Well completion records for the High's Store #86 potable supply well and for the adjacent property to the south, 3707 Federal Hill Road (1700 Jarrettsville Road), were not able to be obtained for this SRS. Well completion records for two adjacent/neighborhood properties to the north of the Site, which includes 3713 and 3717 Federal Hill Road, were made available by High's and have been added to the Well Records package as **Appendix A** and incorporated with the well data summary in **Table 1**. It is noted that the depth-of-rock (and similarly, the depths of casing), as reported for both the 3713 and 3717 parcels, was 88 and 99 feet below ground surface (ft bgs), respectively. These depth-to-rock determinations support the occurrence of a significant overburden aquifer in the vicinity of the Site. As was previously noted, neither the potable supply wells for 3713 or for 3717 Federal Hill Road, when sampled in November 2020, presented any detections of petroleum constituents, including MTBE or benzene. GES would associated the lack of petroleum-related detections from these samples to be related to deep-set protective casings.
- Review of the available well completion records, attached as **Appendix A**, and as summarized in **Table 1**, indicates that among the total 181 parcels within the 1/2-mile radius of the Site, only 56 of these parcels (color-coded blue in **Figures 4, 5 and 6**) had potable well completion records which provided a well casing depth. The average casing depth determined from the 58 potable wells (identified within the 56 parcels) was 49.0 ft bgs. The minimum and maximum casing depths were 20 ft bgs and 96 ft bgs, respectively.

In conclusion, GES has determined that the elevated detections of benzene and MTBE, in onsite well MW-4, during the October 9, 2020 event, was not indicative of an ongoing release. The levels found are related to the historical case on this site that has been well documented and monitored. The reason for the most recent elevated levels reported are likely a result from a combination of inadequate well construction and sampling technique. Compliance testing of the High's UST system in November 2020 indicated no evidence of a recent onsite release. Sampling of potable wells, both onsite and immediately offsite, in November 2020, demonstrated trace to no detections of MTBE (or benzene), which supports that no recent releases from the Site have occurred. Furthermore, MTBE has not been a component of gasoline sold in Maryland since 2006, therefore any detection of MTBE cannot be from a release after 2006.

Although it is unlikely that the historical case at High's Store #86 has caused off site impact beyond what has been addressed in the closed MDE case, GES cannot conclusively rule out the potential for impacts to offsite potable wells within a 1/2-mile radius of the Site from this, or from any other sources. This statement is based on GES's review of the available information, particularly with respect to the well records provided by HCHD and High's. One primary factor, toward the determination of risk for a potable well, is the well's depth of protective casing. GES was only able to find casing depth specifications for 58 potable wells determined to exist within the 1/2-mile radius of the Site. GES' experience with other gasoline retail sites in this region of Harford and Baltimore County suggests that the most protected potable wells are those constructed with casings that extend through the overburden (water table) aquifer and into competent bedrock aquifer where groundwater is stored primarily in fractures. Unfortunately, water production from the competent bedrock zone, in this region of the State, is typically low-yielding. Consequently, installation of historical (and current) potable wells in the area tend to have protective casings completed at depths much shallower than the competent rock interface, within the overburden



aquifer, where plentiful water yields exist but where protection is reduced from shallow surface releases.

Documentation of Abandoned, Historical Wells

GES found well abandonment records for six historical potable wells in the compiled well record (**Appendix A**). These abandonment records are summarized as follows:

Extent of Public Water Supply Reaching Parcels within the 1/2-mile radius

GES used the following Harford County web sites to evaluate the extent of the Harford County public water supply distribution network:

GES’ preliminary review of the Harford County web links indicated that the Harford County public water supply distribution network (west of the town of Bel Air) ended ~4.5 miles southeast from the first parcels within the 1/2-mile radius of the Site. Therefore, all parcels within the 1/2-mile radius of the Site, with an active water supply, would likely source water from an onsite or adjacent parcel potable supply well (or consume tanked and transported drinking water from an offsite source).

GES received an email on April 6, 2021 from a Ms. Carole Coakley-Schaub of the Harford Country Division of Water and Sewer, who confirmed that that there are no properties within 1/2 mile of the Site that receive public water. Ms. Coakley-Schaub further mentioned that the closest current county connections to public water supply were 2.6 miles north of the Site, beginning at 1428 North Bend Road, and to the 6.2 miles south of the Site, beginning at 2105 Rock Spring Road.



Field Reconnaissance Documentation

Field notes generated during the March 24, 2021 field reconnaissance event within 1/2-miles of the Site are compiled and included with this correspondence as **Appendix B**. Observations from the field event were also included in the “Notes” column presented in **Table 1**.

Written Documentation of Findings and List of Persons Contacted

The submission of this SRS report, in combination with the attached well record information, SRS radius maps, and field observations should provide a satisfactory demonstration of due diligence as performed by GES, on behalf of High's, toward the completion of the SRS requirements stipulated in the January 27, 2021 MDE directive.

GES greatly appreciates the efforts of Ms. Cari Biscoe and others from the HCHD in assisting with the compilation of the 1/2-mile well records package for this SRS. Other than GES's coordination with the HCHD, and the correspondence with Ms. Carole Coakley-Schaub of the Harford County Division of Water and Sewer, no additional entities were contacted by GES or High's to complete this SRS.

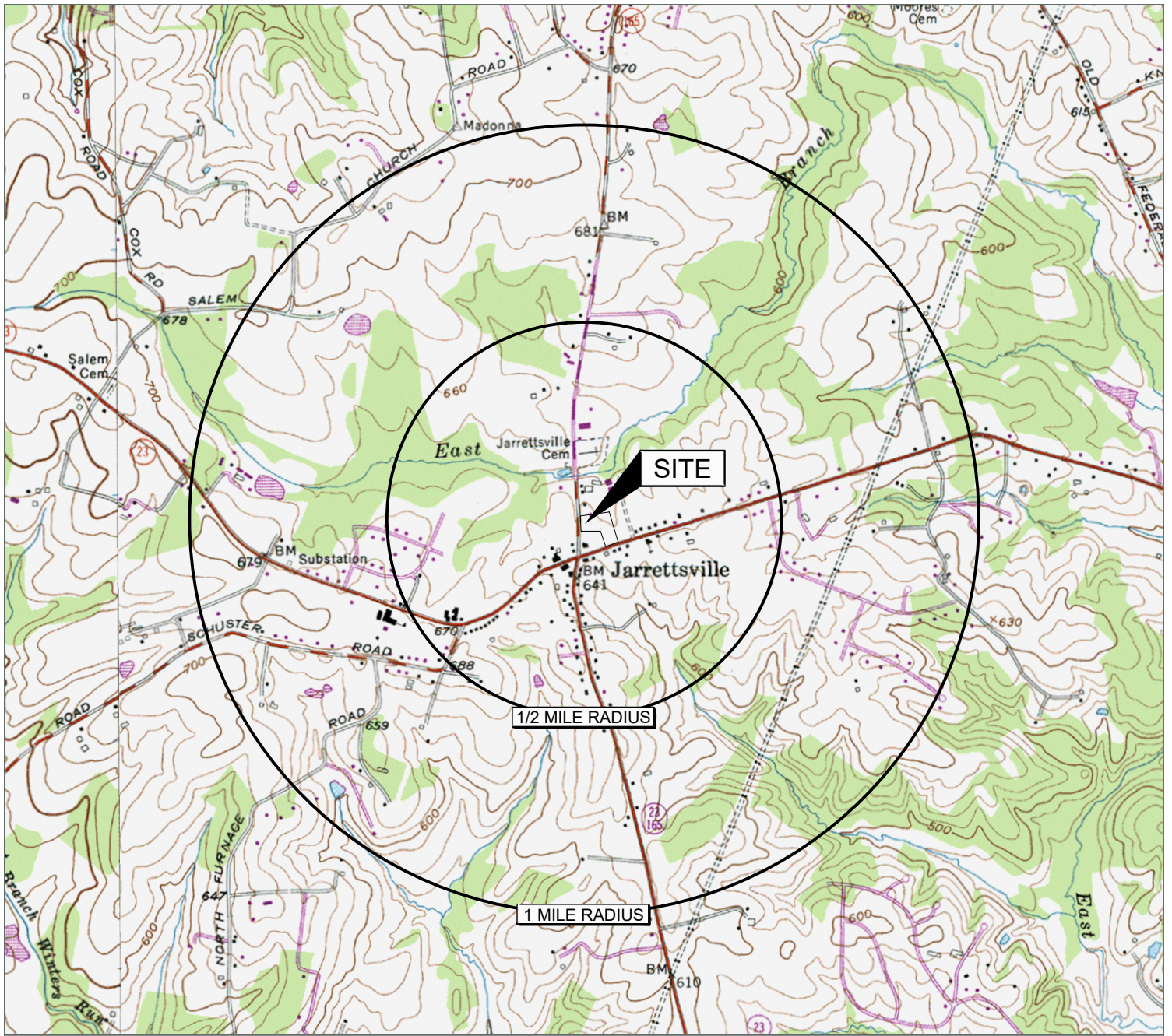

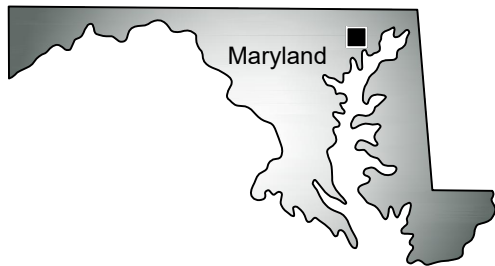

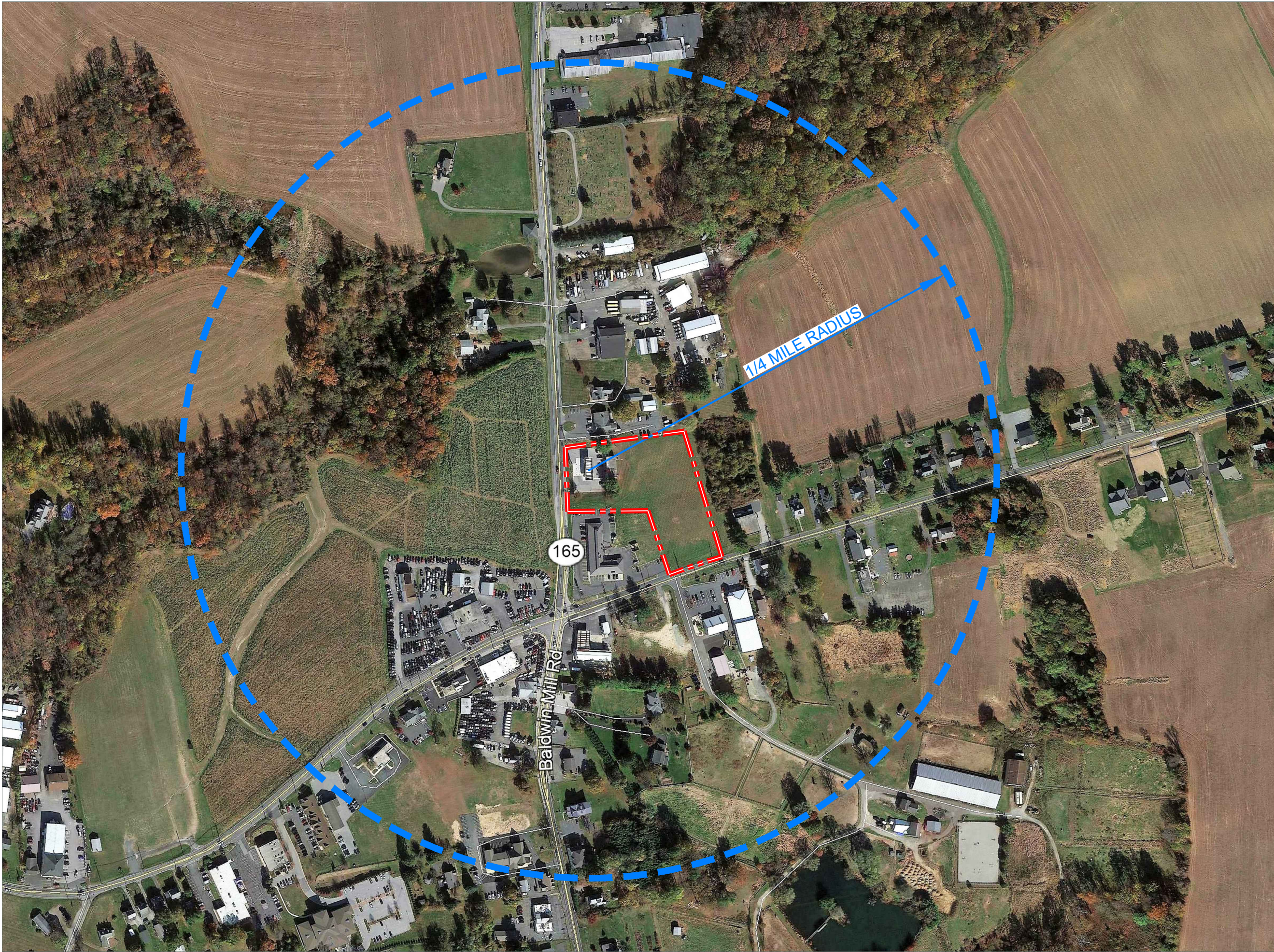

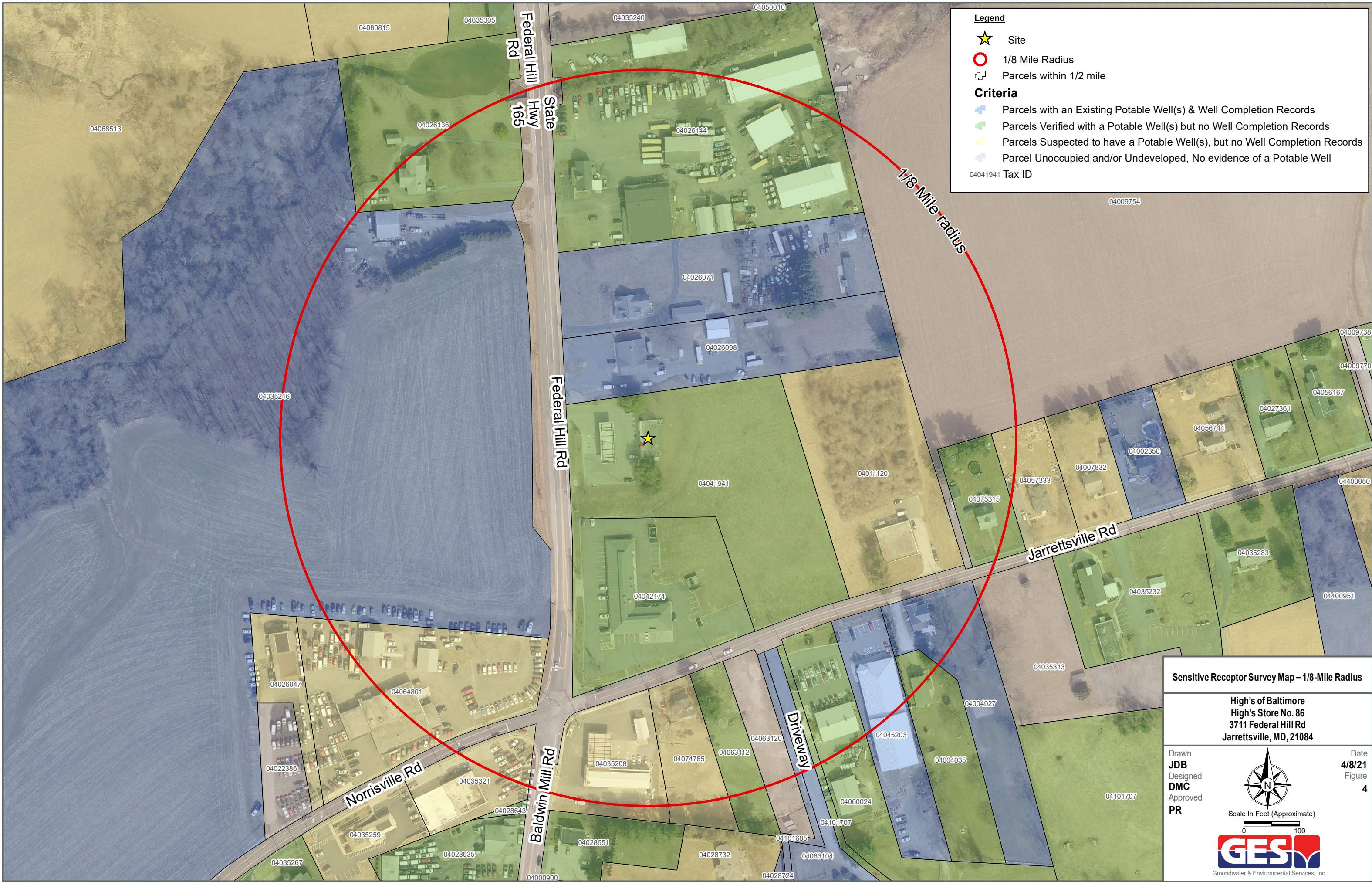

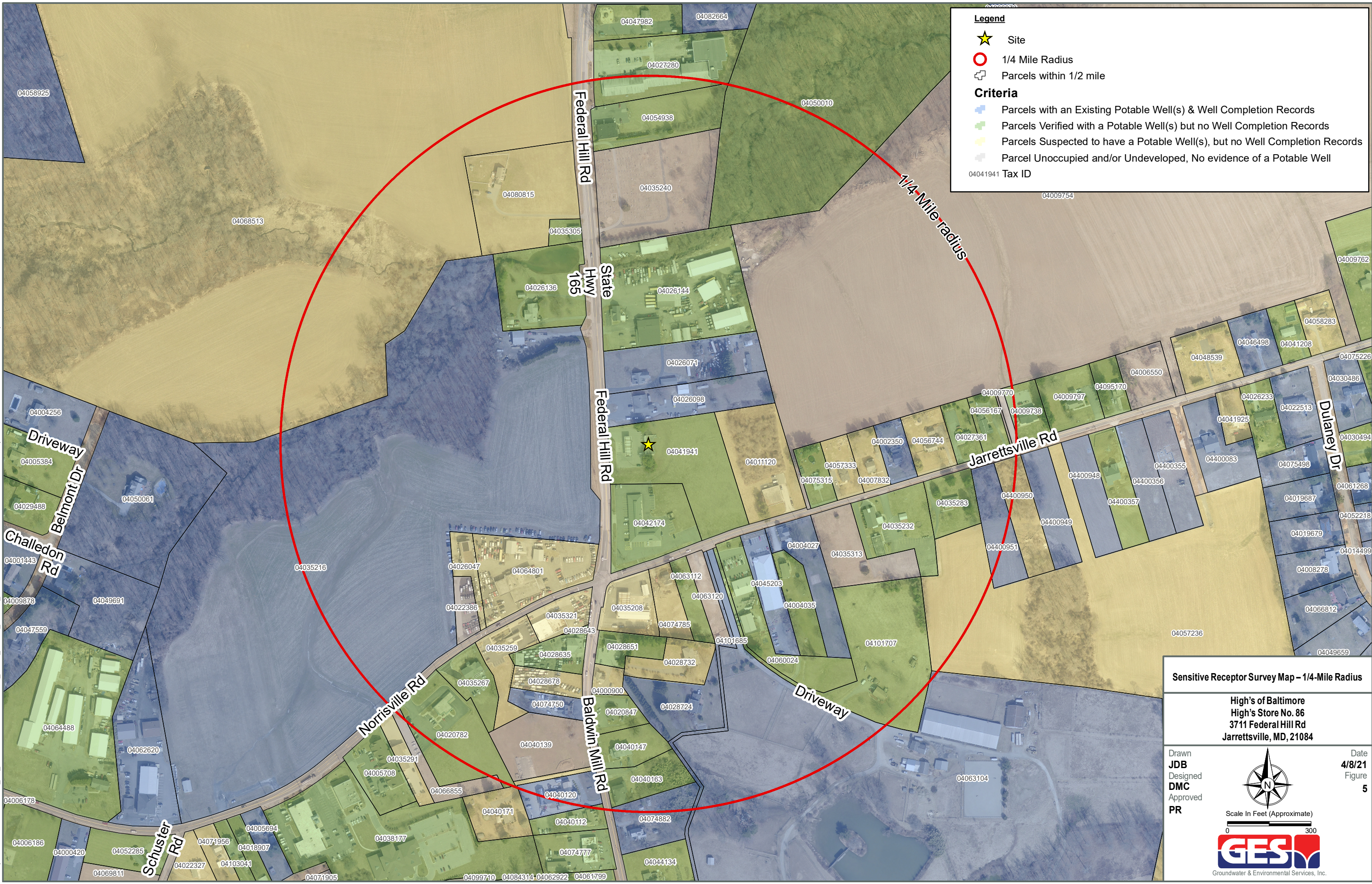

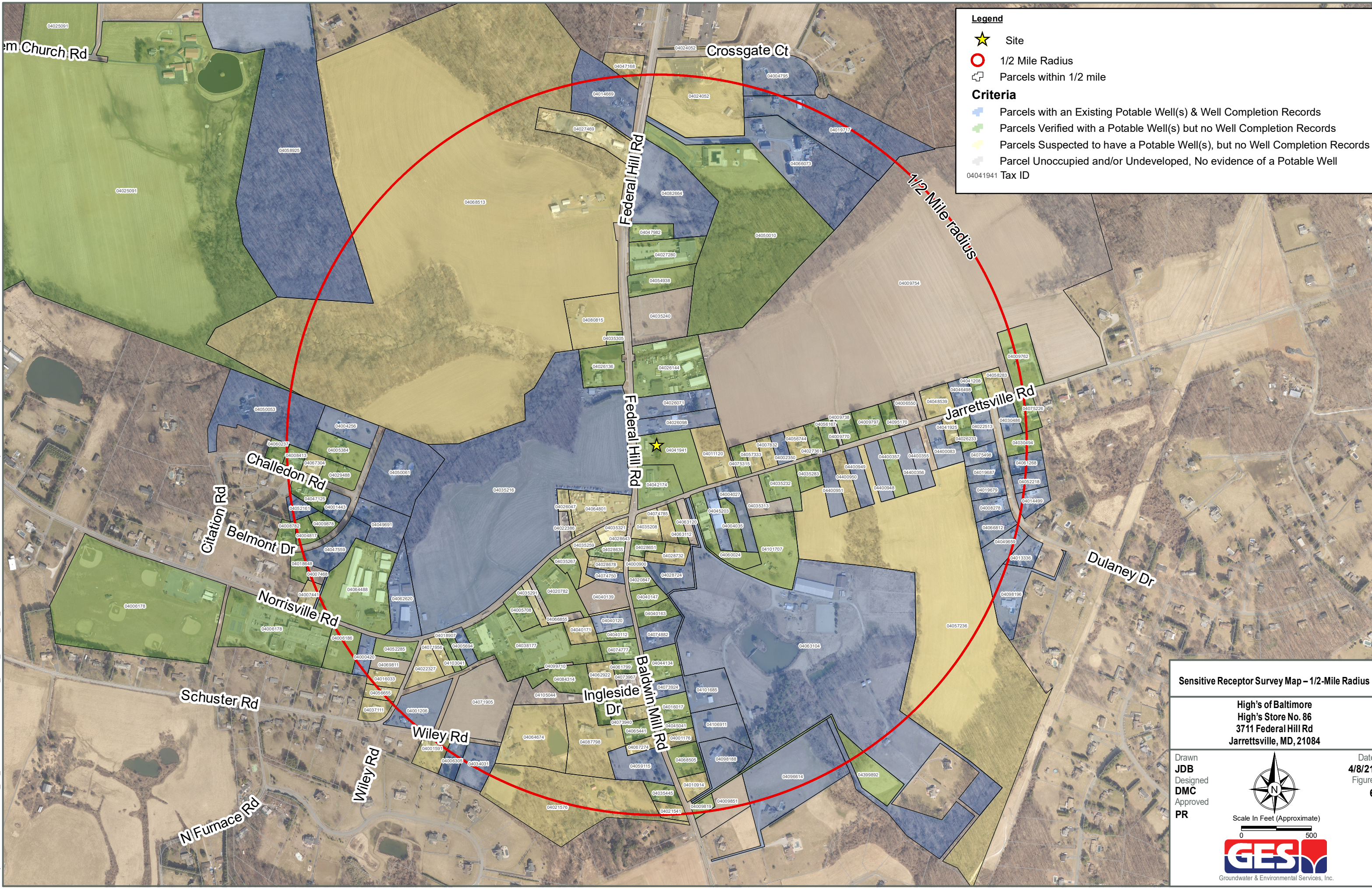
