### 3. APPLICANT CERTIFICATION

By signing this application, I affirm that I have read and understood the requirements of Maryland Law COMAR 26.12.01.01B.4-B.12. I understand that, among other applicable provisions of these regulations,		
a. The filing of a radiation machine assembly report with the Department or the Federal Government does not substitute for the facility owner applying for registration of the facility under COMAR 26.12.01.01B.4;		
b. Persons moving radiation machines shall comply with Section B.12 "Assembler and or Transfer or Service Obligation." I recognize that Maryland law, unlike Federal law, requires persons to notify the State of the sale, lease, transfer, loan, or disposal of any radiation machine in addition to the assembly of new ones; and		
c. To comply with paragraph b. above, a person must use a State form or State approved alternate. The Federal form FDA 2579 will not meet the requirements of the Maryland law.		
<b>d. All service and PM technicians who initiate exposures during testing, calibration, or repair of a radiation producing machine are considered occupationally exposed Radiation Workers and as such are required to wear film badges at all times. Badges are to be worn at the collar. Monitoring of film badge reports is required. Random compliance audits will take place. (See COMAR 26.12.01.01D.502.)</b>
