Maryland Department of the Environment - Alvin Bowles

- Lead Safe Regulations now in effect
- Can now have an affected property certified as Lead Safe outside of the qualified offer
- Will also change the inspection requirement time for 15 days to 30 days for the QO Lead Safe
- Lead in Products-When the Federal Law passed in August of 2008 it preempted the Lead in Products Law that Maryland had on the books, so in this legislative session Maryland is hoping to clear up any preemptions. This passed in the House and is now in the Senate.

LEGISLATIVE UPDATE – Ruth Ann Norton, CELCP

House Bill ("HB") 236, Senate Bill ("SB") 361- Reduction Lead Risk in Housing-Lead Paint Dusting Testing

- "Good" Hearing on the Bill in the House
- MDE made recommendations for amendments
- Right now it is sitting in the Environmental Matters Committee and hopefully it will move
- Current Oppositions to the Bill from Property Owners
 - You don't need to fix what is working (meaning the current law is lowering BLL)
 - Claim that it would cost owners an additional 3-5 thousand dollars, per property, not supported by the fiscal notes that argued that this was not the case
 - If children where tested there would not be any issues
- CECLP urging the commission to reach out for support of the bill
- Pat McLaine recommending the Commission to continue to support the Dust Bill

House Bill ("HB") 1526, Senate Bill ("SB") 907- Demolition Work-Safety Provisions and Permitting.

- Baltimore City has already adopted
- DLLR is out of it

Lead Paint Manufacturing Bill

- Baltimore City Bill only
- Sue Lead Paint Manufacturers on market share and not nuisance based
- Only two manufactures left (DuPont and Sherwin Williams)
- Hearing on March 18, 2009
- Prospects of it passing are better than they have been in the past
- Current Oppositions
 - Concerns about potential changes to tort law
