MARYLAND DEPARTMENT OF THE ENVIRONMENT:

Recommendation: That the Board of Public Works approve up to \$4,258,000 in grant funding for the Applicants listed below, to upgrade On-site Disposal (Septic) Systems (OSDS) with best available technology (BAT) for nitrogen removal, using the Bay Restoration (Septic) Fund.

Program Description: The above grant recipients will prioritize application for funding as follows:

- Counties with OSDS in critical areas: To ensure sufficient grant funds are available to comply with HB 62 (2010 session), between July 1, 2010 and December 31, 2010, the grant funds shall only be used for BAT installations on failing OSDS in critical areas.
- Counties with no OSDS in critical areas: Between July 1, 2010 and December 31, 2010, the grant funds shall only be used for BAT installations on failing OSDS.

Owners of Failing OSDS in critical areas are eligible for 100% reimbursement of BAT cost as grant. Homeowners with OSDS not in critical areas will be eligible to be reimbursed from 25% to 100% of BAT cost as grant, based on an income criterion, while businesses, non-residential or rental property owners with OSDS not in critical areas are eligible for 25% reimbursement of BAT cost as grant.

Authority: Sections 9-1601 through 9-1622 of the Environment Article, Maryland Code, known as the Maryland Water Quality Financing Administration Act.

The project is consistent with State Clearinghouse comments and recommendations.
