**DESCRIPTION OF CERTIFIED PROJECT:** Perform maintenance dredging in an area of approximately 92,364 square feet (2.12 acres) within an existing stormwater pond by mechanically removing approximately 4,779 cubic yards of accumulated sediment via bucket excavator. After removal of accumulated sediment, the pond will be graded to return elevations to the original as-built design.

### **WATER QUALITY CERTIFICATION**
