Your project did not qualify for approval under the Maryland State Programmatic General Permit (MDSPGP); therefore, a separate review and issuance of the federal permit will be required by the U.S. Army Corps of Engineers. <u>The federal permit is not attached.</u>

Additionally, your project required a Wetlands License to be approved and issued by the Maryland Board of Public Works (BPW). <u>The Wetlands License will be sent to you by the BPW's Wetlands</u> <u>Administrator.</u>

PROJECT DESCRIPTION

- Hydraulically dredge a new 808-square foot area to a depth of 3 feet at mean low water and to deposit approximately 35 cubic yards of material at the Bird River DMP site, and to provide for periodic maintenance dredging for six years;
- Construct a 10-foot long by 6-foot wide pier extension; remove an existing 10-foot by 10-foot platform and relocate it adjacent to the 10-foot long by 6-foot wide pier extension; install a 12-foot by 10-foot boat lift with associated piles, all extending 60 feet channelward of the mean high water line.

GENERAL CONDITIONS

A. This Certification does not obviate the need to obtain required authorizations or approvals from other State, federal or local agencies as required by law.

<u>Statement of Necessity for Condition</u>: The condition is necessary to ensure that water quality standards are met under unique circumstances for discharges which may otherwise qualify under the certified Nationwide Permits.

SPECIAL CONDITIONS

A. Due to the presence of SAV and anadromous fish, the Certificate Holder shall perform no in water work between February 15 and October 15 of any year.

<u>Statement of Necessity for Conditions:</u> This time of year condition is necessary to maintain designated use for support of estuarine and marine aquatic life and shellfish harvesting. Discharges may result in increases in turbidity which may violate water quality standards for clarity needed to support SAV designated uses and uses for aquatic life.

The Certificate Holder shall submit a detailed dredged material disposal plan to and approved by the Maryland Department of the Environment's (MDE) Water and Science Administration, Tidal Wetlands Division, within six months, of the effective date of this license or prior to commencement of any work under the License, whichever comes first. The dredged material disposal plan shall include the Licensee's choice of mechanical or hydraulic dredging. Failure to comply with this condition shall result in automatic suspension of the license.

<u>Statement of Necessity for Conditions:</u> This condition is necessary to ensure that dredged material is removed and placed at a site and in a manner which prevents its re-entry into Waters of the United States, where its release may result in failure to meet turbidity standards and failure to meet designated uses for Turbidity; Discharge of dredged material may interfere with designated uses or support of estuarine and marine aquatic life and shellfish harvesting and may result impacts to water quality, clarity, growth and propagation of fish, other aquatic life, and wildlife.

- E. The Certificate Holder shall conduct subsequent maintenance dredging within the scope of the State license in terms of authorized dredge area and authorized depths. The Certificate Holder shall:
 - 1. Dredge no more than 500 cubic yards of material at each maintenance dredging.
 - 2. Comply with all applicable conditions of this license.
 - 3. Submit a detailed dredged material disposal plan to be approved by the Water and Science Administration, Tidal Wetlands Division prior to the start of dredging.
 - 4. Notify and receive approval from the Water and Science Administration Compliance Program a minimum of 10 days prior to the start of each maintenance dredging operation.

<u>Statement of Necessity for Conditions:</u> The limits on the scope of maintenance dredging are necessary to ensure that no discharges would violate water quality standards and designated uses for water clarity, turbidity, growth and propagation of fish, other aquatic life, and wildlife; and water contact recreation.

F. The Certificate Holder shall stake the dredge area and receive approval from the Water and Science Administration, Compliance Division prior to the start of dredging.

<u>Statement of Necessity for Conditions:</u> This condition is necessary to ensure that discharges will be conducted in a manner which do not violate water quality criteria nor interfere with designated uses.

G. The Certificate Holder shall conduct a post dredge bathymetric survey and forward to the Water and Science Administration, Tidal Wetlands Division within 45 days after the termination of any phase of dredging.

<u>Statement of Necessity for Conditions:</u> The condition is necessary to ensure that discharges associated with dredging result in water depths which are appropriate to support designated uses of fishing and water contact recreation and propagation of fish, other aquatic life and wildlife; and ensure that no discharges are unsightly, create a nuisance, change to an objectionable color or interferes with designated uses.

I. If the U.S. Coast Guard's approval alters the proposed pipeline route, the certificate holder shall submit an application and revised plans to MDE for a modification to the State license.

<u>Statement of Necessity for Conditions:</u> The condition is necessary to ensure that the discharge will not interfere with designed uses for water contact, recreation, and fishing. The condition is necessary to ensure a nuisance is not created.

J. To ensure navigational safety, the Certificate Holder shall conspicuously mark the location of the pipelinealong the entire length of the pipeline route. The Certificate Holder shall verify that the signs/markers on the pipeline remain visible and conspicuous throughout the dredging operations.

<u>Statement of Necessity for Conditions:</u> The condition is necessary to ensure that the discharge will not interfere with designated uses for water contact, recreation, and fishing; nor create a nuisance.

L. In the event of any inadvertent releases of dredged material into State tidal wetlands from a pipe breakage, all dredging operations shall immediately cease. The Certificate Holder shall take steps to stop all dredged material from entering State tidal wetlands and shall immediately notify MDE's Compliance Program of the pipe breakage. The Certificate Holder shall not resume dredging operations until receiving approval from MDE's Compliance Program.

Turbidity in the discharge may not exceed 150 units at any time or 50 units as a monthly average. Units shall be measured in Nephelometer Turbidity Units. A logbook of all turbidity monitoring shall be kept on site. The dredger shall have a person at the discharge point of the DMP in constant radio communication. If a problem is incurred, the dredging operation shall be immediately shutdown until the reason for the problem can be ascertained and rectified.

<u>Statement of Necessity for Conditions:</u> The condition is necessary to ensure that no dredged material will result in a violation of water quality standards for turbidity and interfere with designated uses.
